Title: *Christ and the Church: Duo in Carne Una*. A study of the union of Christ and the members of His Mystical Body from the vantage point of its Bodiliness.

Abstract: This study undertook a metaphysical and dogmatic analysis of a thesis proposed by certain post-war scriptural exegetes, who argued for a somatically real interpretation of Paul's corporeal ecclesiological language ("soma christou"). This was undertaken through research into the Christological and Eucharistic writings of three intellectually related thinkers: Cyril of Alexandria in the 5th century, Thomas Aquinas in the 13th century, and Matthias Scheeben in the 19th. We were able to provide a dogmatic exposition of the notion that Christ's 'one flesh' union with His Church is to be understood with a high level of corporeal realism.
