Important Note

Your application will not be complete until you have filled out and submitted this form. Also, you will not be considered eligible for Additional Financial Aid until you have submitted **SECTION B of this form before the start of each academic year**. If you want to apply for a scholarship other than the additional (internal) ITI Scholarships listed on the ITI website, you need to contact us by the 31st January before your next academic year. Those from the USA can fill out the FAFSA on the internet at www.fafsa.ed.gov, as US Federal Student Loans are available for the MMF, STM, STL and STD programs. The school code for ITI is G34603. There is no additional financial aid available for Studium Generale students.

Financial Policies

1. The tuition fee for MMF, STM and STL programs is €6000 per academic year. STD students pay for each class they attend. **Please see our website for further details on student costs and additional financial aid.**
2. The actual calculated costs of tuition per student is approximately €20.000 per year. The cost for our students, however, is deliberately kept at a minimum to enable qualified persons from all over the world to study at the International Theological Institute (ITI). Every accepted student, therefore, receives a tuition waiver of over €14.000 per year of study. To continue to be able to grant tuition waivers to our students in the future, we encourage those persons who possess the financial means to help by making additional contributions to help cover the actual tuition costs.
3. The admissions committee chooses students for admission primarily on academic grounds.
4. On a yearly basis the financial aid package of each student is reviewed in relation to academic performance and financial need.
5. Community service: since the ITI is enriched by a community life, all students, regardless of financial or academic standing, are expected to contribute 2 hours per week to assist with the maintenance of the chapel, living areas, library and other facilities.
